NOTIFICATION

No.FD.SO(Reg-II)VII-II/2023/82-232. With the prior approval of the Provincial Cabinet and in partial modification of Finance Department's policy Notification No.SO.FD(R-II)/VII-II/2020/344-443 dated 11th August, 2020, the Government of Balochistan is pleased to enhance the existing rates of compensation package with immediate effect in respect of bereaved families of Shaheed employees (Officers/Officials) of Balochistan Police and Levies Force, whose death takes place as a result of sectarian violence or due to falling victim to any type of terrorist activity such as ethnic, sectarian or any other subversive activity irrespective of either during the performance of their respective official duties or otherwise as per following rates:
