
Subject: - **FORMAT TO BE FOLLOWED IN MAKING AMENDMENTS OR REVISIONS OF RULES OR LAWS.**

The undersigned is directed to refer to the subject cited above and to state that it has been observed that very often the administrative departments share draft amendments or revisions of laws and rules for input of Finance Department without providing a comparative statement and rationale of the proposed amendments or revisions in the same, which if provided would be more useful in reviewing and assessing the proposed changes or revisions.

2. It has also been observed that in some cases the departments propose altogether new laws or rules by repealing the existing legislations without any apparent reasons.

Above in view, it is requested to kindly propose amendments in the existing laws or rules, if already in place, along with a rationale or justification for insertion/deletion of any provisions in the said laws/rules.
