RELAXATION/CONDONATION IN LENGTH OF SERVICE BEYOND ONE YEAR TOWARDS PENSIONARY BENEFITS.

The undersigned is directed to refer to the subject cited above and to state that it is has been observed that the Administrative Departments invariably/consistently recommend the cases for relaxation/condonation in length of service beyond one year towards pensionary benefits for consideration of the competent authority i.e. Hon'ble Chief Minister Balochistan.

- However, sub-rule (4) of Rule 2.12 of the Balochistan Civil Servants
 Pension Rules, 1989 provides that a deficiency of one full year or more shall not be
 condoned. Hence, the ibid rules don't allow condonation of deficiency in qualifying
 service beyond 01-year.
- 3. Further, to state that an employee who has rendered five years qualifying service or more but less than ten years, the Administrative Department(s) may dispose of such cases under sub-rule (2) of rule 4.6 of the Balochistan Civil Servants Pension Rules, 1989. For ease of reference, the same is reproduced here under:

"If a civil servant dies in service, the rate shall be one and half month's emoluments for each completed year of service. If the emoluments of a civil servant have been reduced during the last twelve months or thirty six months of his service, as the case may be, otherwise than as penalty, average emoluments may, at the discretion of the authority which has the power to sanction gratuity, be substituted for emoluments"

4. In view of above, it is, advised that as per directions of the worthy Chief Secretary Balochistan that in future not to initiate case(s) for relaxation/condonation in length of service beyond one year towards pensionary benefits for consideration of the competent authorities unless specifically directed by the Hon'ble Chief Minister Balochistan or advised by the Chief Secretary.
