#### GRANT OF AD-HOC RELIEF ALLOWANCE-2023 TO THE Subject: -CIVIL SERVANTS OF BALOCHISTAN GOVERNMENT.

The Government of Balochistan has been pleased to sanction an Ad-hoc Relief Allowance - 2023 in favour of all Provincial Government employees including contingent paid staff and contract employees employed against civil posts in Basic Pay Scales on andard terms & conditions of contract appointment with effect from July, 2023 and shall freeze on as below: -

i) BPS-1 to BPS-16

@ 35% of the Basic Pay as on 30-06-2023

ii) BPS-17 and above

@ 30% of the Basic Pay as on 30 .-06-2023

The amount of this Ad-hoc Relief Allowance-2023:-2.

- will be subject to Income Tax. (i)
- will be admissible during leave and entire period of LPR (ii) except during extra ordinary leave.
- will not be treated as part of emoluments for the purpose (iii) of calculation of Pension/Gratuity and recovery of House
- will not be admissible to the employees during the tenure (iv) of their posting/deputation abroad; and
- will be admissible to the employees on their repatriation (v) from posting/deputation abroad at the rate and amount which would have been admissible to them had they not been posted abroad.

- 3. The term "Basic Pay" for the purpose of Ad-hoc Relief Allowance- 2023 will also include the amount of the personal pay granted on account of annual increment (s) beyond the maximum of the existing pay scales.
- 4. The expenditure involved in the above Ad-hoc Relief Allowance-2023 will be adjusted in revised budget estimates 2023-24.
