**Subject: GRANT OF SPECIAL CONVEYANCE ALLOWANCE TO
DISABLE EMPLOYEES.**

With reference to this Department's circular No.FD(R-I)
V-I/2019/3957-4077 dated 26th November, 2019 the Government of
Balochistan Finance Department has been pleased to revise the rates
of Special Conveyance Allowance of disable employees of this Provincial
Government from Rs.2000/- per month to Rs.4000/- per month, in
addition to normal conveyance Allowance with effect from 1st July,
2023. The following terms and conditions will be applicable for
admissibility of this allowance: -

- a. It will be admissible to those Government Employees who have
been appointed against disable employees' quota, or they have
been declared/certified as disable by an authorized Medical
Board thereafter during service;
- b. It will not be admissible during leave of any kind, except medical
leave upto one month or casual leave.
