No.FD(R-I)II-29/2023/4271-4390/ With reference to this Department's circular No. FD(R-I)II-29/2018/1601-1720 dated 16th July, 2018 the Government of Balochistan Finance Department is pleased to sanction increase in Minimum Pension from Rs.10,000/- p.m. to Rs.12,000/- p.m. to Civil Pensioners of the Government of Balochistan w.e.f 1st July, 2023.

2. Similarly, Family Pension allowed to the family of a retired Provincial Government employee of this Province under the Balochistan Civil Servants (Pension) Rules, 1989 has also been increased from current rate of Rs.7,500/- p.m. to Rs.9,000/- p.m. w.e.f. 1st July, 2023.
