3. Deputy Prosecutor Generals (BPS-18).
4. Deputy District Public Prosecutors (BPS-18)
5. Assistant District Public Prosecutors (BPS-17).

Terms & conditions

- a) This Allowance will be subject to Income Tax;
- b) This Allowance will be admissible during leave and entire period of L.P.R except extra ordinary leave;
- c) The Allowance will not be treated as part of emoluments for the purpose of calculation of Pension/Gratuity and recovery of House Rent;
- d) The Allowance will not be admissible to the employees during the tenure of their posting/deputation abroad, which means outside Prosecutor General Office with immediate effect.
- e) The Allowance will be admissible to the employees on their repatriation from posting/deputation abroad at the rate and amount which would have been admissible to them, had they not been posted abroad;
- f) The Allowance will be admissible during the period of suspension;
