## NOTIFICATION

No.FD(R-I)V-1/2023/5409-5508. In compliance with the judgment of the Honorable High Court of Balochistan passed on 30.12.2021 vide C.P No.883/2019, and with prior approval of the Government of Balochistan (i.e Provincial Cabinet), Finance Department is pleased to allow Special Judicial Allowance to the employees (Staff members) of Balochistan District Judiciary equal to one initial basic pay of their respective Pay Scale as per pay scale 2017, plus 50% of running Basic Pay as drawn upto 30th June, 2022 of pay scale 2017, with effect from 01st January, 2022 with the following terms and conditions in true spirit: -

- This Allowance shall be subject to Income Tax;
- The Allowance shall not be admissible to the employees/staff members during the tenure of their posting/deputation within country as well as abroad;
- The Allowance shall be admissible to the entitled employees upon their (c) repatriation from posting/deputation from within country or abroad at the rate and amount which would have been admissible to them, w.e.f. date of charge assumption;
- This Allowance shall not be admissible during all kinds of leave except Casual Leave;
- The Allowance shall not be treated as part of any sort of emoluments towards (e) calculation of Pension/Gratuity/Commutation;
- The Allowance shall not be admissible during the period of suspension; and (f)
- The increase, hereby allowed, shall be provisional until further orders and shall be reversible to the earlier level ab-initio and recoverable from employees (staff members) of Balochistan District Judiciary in case the Honorable Supreme Court of Pakistan decides the case in favour of the Government of Balochistan as the subject case is sub-judice before Honorable Supreme Court of Pakistan vide CPLA No. 318-Q/2021.
