- These Allowances will not be admissible to the employees during the tenure of their posting/deputation abroad, which means outside Prosecutor General Office with immediate effect;
- These Allowances will be admissible to the employees on their repatriation from posting/deputation abroad at the rate and amount which would have been admissible to them, had they not been posted abroad;
- These Allowances will be admissible during the period of suspension;
